## **Cookie Policy**

As Başkent University Istanbul Hospital, we strive to act in accordance with the provisions of the Personal Data Protection Law No. 6698, the decisions of the Personal Data Protection Board and all legislation in order to process your personal data in accordance with the law, and we take all necessary precautions and measures to comply with the provisions of the European Union Data Protection Regulation to the extent appropriate. In this context, we would like to inform you about the types of cookies we use, the purposes of using cookies, and the settings, management and deletion of these cookies in order to provide a better user experience by observing the privacy and personal data protection rights of our visitors. Possible changes to our Cookie Policy will be published on this page. In this context, you will be provided with the opportunity to receive up-to-date information about which information is stored and how this information is used.

Like many other websites, we use "cookies". Cookies are small text files that are transferred to your hard drive by a web page server. In this way, we automatically obtain certain data such as your IP address, the browser used, the operating system on your computer and your internet connection. Cookies cannot be used to run programs or to send viruses to your computer. With the information contained in cookies, we can only facilitate navigation and ensure that our websites are displayed correctly.

We use cookies and similar technologies, such as mobile application identifiers, to recognize you across services, learn about your interests on and off our services, enhance your experience, increase security, measure the use and effectiveness of our services, and serve ads. You can control cookies through browser settings and other tools.

There are four types of cookies according to their intended use: Session Cookies, Performance Cookies, Functional Cookies, and Advertising and Third Party Cookies. Başkent University Istanbul Hospital uses mandatory cookies and performance/analytic cookies on its websites. Session cookies are temporary cookies that are kept in the user's browser until the user leaves the Başkent University Istanbul Hospital website. Persistent cookies are cookies that remain in the user's browser unless deleted by the user. The lifespan of cookies varies depending on the user's browser settings.

In any case, the data we collect will not be shared with third parties without your consent. Of course, you can always view our website without cookies. Internet browsers are always set up to accept cookies. You can always stop the use of cookies through your browser settings. To learn how to change these settings, please use your browser's help function and our cookie management page. Please note that certain features of our website may not work if you stop the use of cookies.
