1)DATA CONTROLLER:

2)PURPOSES OF PROCESSING PERSONAL DATA, CATEGORIES OF PERSONAL DATA TO BE PROCESSED, LEGAL GROUNDS FOR PROCESSING AND METHOD OF COLLECTING PERSONAL DATA:

Based on the above-mentioned purposes and legal reasons, it is processed manually or automatically by hand delivery, e-mail, filling in the relevant form and virtual data entry, and evaluating the results of the transaction.

3)TO WHOM AND FOR WHAT PURPOSE CAN THE PROCESSED PERSONAL DATA BE TRANSFERRED: Your personal data will be transferred by BAŞKENT UNIVERSITY ISTANBUL HOSPITAL;

- Carrying out the patient's medical diagnosis, diagnosis and treatment processes
- Providing information to authorized persons, institutions and organizations,
- Following up and carrying out legal transactions,
- Carrying out hospital promotion transactions,
- Carrying out treatment process activities and ensuring their continuity,

It may be transferred to authorized public institutions and organizations and to real persons or private legal entities with whom we have a contractual relationship for its intended purposes.

4)RIGHTS OF THE RELEVANT PERSON:

Within the scope of Article 11 of the Law, which “regulates the rights of the relevant person”, we would like to remind you that you have the right to learn whether your personal data has been processed, to request information if processed, to learn the purpose of processing and whether it is used in accordance with its purpose, to learn the third parties to whom it has been transferred domestically or abroad, to request correction if it has been processed incompletely or incorrectly, to request deletion or destruction within the framework of the conditions stipulated in Article 7 of the KVKK, to request notification of correction and deletion operations made to third parties to whom it has been transferred, to object to the emergence of a result against you due to analysis exclusively by automated systems, and to request compensation for damages if you suffer damage due to processing of your data in violation of the KVKK. You can submit your requests by filling out and signing the Application Form prepared in accordance with the Law on the Protection of Personal Data on the Başkent University Website in accordance with the “Communiqué on the Procedures and Principles of Application to the Data Controller”, to the address “Altunizade, Kısıklı Caddesi Oymacı Sk.
